CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVEN LYNN STONEBREAKER
63235 HALLEY ROAD
LA GRANDE, OREGON 97850

confirms the right to use the waters of THE GRANDE RONDE RIVER, a tributary of SNAKE RIVER, for IRRIGATION OF 146.0 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UNION COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at Page 1. The date of priority is 1872.

The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed THREE ACRE FEET PER ACRE IN ANY IRRIGATION SEASON, DIVERTED AT A RATE OF NOT TO EXCEED ONE-FORTIETH OF A CUBIC FOOT PER SECOND PER ACRE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

ORODELL DITCH - SW 1/4 SW 1/4, SECTION 31, TOWNSHIP 2 SOUTH, RANGE 38 EAST, WM; 1858.33 FEET SOUTH AND 80.84 FEET EAST FROM THE W 1/4 CORNER, SECTION 31.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SW 1/4	29.0 ACRES
SE 1/4 SW 1/4	40.0 ACRES
NE 1/4 SE 1/4	16.8 ACRES
NW 1/4 SE 1/4	20.2 ACRES
SW 1/4 SE 1/4	20.0 ACRES


TOWNSHIP 2 SOUTH, RANGE 38 EAST, W.M.

This certificate is issued to confirm a change in PLACE OF USE approved by an orders of the Water Resources Director entered JULY 20, 1992, APPROVING TRANSFER APPLICATIONS 6520, 6521 AND 6522 and ALONG WITH CERTIFICATES 67641 AND 72397 supersedes Certificate 6499, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
