CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ERNEST AND LOLA ZIELINSKI ARTHUR M. AND CHARLOTTE R. MCKAY 5270 HAZEL GREEN ROAD SALEM, OREGON, 97303,

confirms the right to use the waters of WELLS 2 AND 3 in the LITTLE PUDDING RIVER BASIN for IRRIGATION OF 40.0 ACRES FROM WELL 2 AND IRRIGATION OF 224.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 43.7 ACRES FROM WELL 3.

This right was perfected under Permit G-3244. The date of priority is FEBRUARY 21, 1967. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.67 CUBIC FEET PER SECOND (CFS), BEING 0.41 CFS FROM WELL 2 AND 1.26 CFS FROM WELL 3, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 2 - SE% NW%, AS PROJECTED WITHIN DELORES DLC 51, SECTION 5, T 6 S, R 2 W, W.M.; 1150 FEET NORTH AND 2160 FEET EAST FROM THE W% CORNER OF SECTION 5.

WELL 3 - LOT 1 (SE% SE%), SECTION 32, T 5 S, R 2 W, W.M.; 20 FEET SOUTH AND 2640 FEET WEST FROM THE NW CORNER OF DOUGHERTY DLC 101.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
