CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LARRY A. HAUN

COOS BAY, OREGON 97420

confirms the right to use the waters of A SPRING AND TWO RESERVOIRS CONSTRUCTED UNDER PERMIT R-11983, tributaries of ROSS SLOUGH, for DOMESTIC USE EXPANDED FOR ONE HOUSEHOLD.

This right was perfected under Permit 53373. The date of priority is JANUARY 27, 1997. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.01 CUBIC FOOT PER SECOND FROM THE SPRING AND 0.1 ACRE-FOOT EACH YEAR FROM THE RESERVOIRS, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SPRING - NW 1/4 NW 1/4, SECTION 6, TOWNSHIP 26 SOUTH, RANGE 12 WEST, W.M.; 108 FEET SOUTH AND 529 FEET EAST FROM THE NW CORNER OF SECTION 6;

RESERVOIR 1 - NW 1/4 NW 1/4, SECTION 6, TOWNSHIP 26 SOUTH, RANGE 12 WEST, W.M.; 53 FEET SOUTH AND 462 FEET EAST FROM THE NW CORNER OF SECTION 6; AND

RESERVOIR 2 - NW 1/4 NW 1/4, SECTION 6, TOWNSHIP 26 SOUTH, RANGE 12 WEST, W.M.; 130 FEET SOUTH AND 566 FEET EAST FROM THE NW CORNER OF SECTION 6.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW 1/4 NW 1/4  
SECTION 6  
TOWNSHIP 26 SOUTH, RANGE 12 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for review and approval.

- B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the permit. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

Failure to comply with any of the provision of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.


The right to use water for the above purpose is restricted to beneficial use, without waste, on the lands or place of use described. The water user is advised that new regulations may require use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including prior rights for maintaining instream flows.

The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
