CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FORREST AND YVONNE CARROLL

confirms the right to use the waters of TWO WELLS in the WALLA WALLA RIVER BASIN for IRRIGATION OF 19.5 ACRES.

This right was perfected under Permit G-1279. The date of priority is MARCH 2, 1959. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.24 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

OLD WELL - SW 1/4 SE 1/4, SECTION 24, TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.; 800 FEET NORTH AND 1330 FEET WEST FROM THE SE CORNER OF SECTION 24; AND

NEW WELL - SW 1/4 SE 1/4, SECTION 24, TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.; 42 FEET NORTH AND 64 FEET EAST FROM THE S 1/4 CORNER OF SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

W 1/2 SW 1/4 SE 1/4 19.5 ACRES
SECTION 24
TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.

The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

If substantial interference with an existing water right occurs due to withdrawal of water from the new point of appropriation, the use of water from the new well may be discontinued or reduced to mitigate the interference.


The quantity of water diverted at the new point of appropriation, together with the quantity diverted at the old point of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

When required by the Department, the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water used. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered APRIL 8, 1997, and supersedes Certificate 27424, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
