CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

E. H. FOSSEN  
ROUTE 2, BOX 64  
JACKSONVILLE, OREGON 97530

confirms the right to use the waters of the APPLGATE RIVER, a tributary the ROGUE RIVER, and A SPRING, a tributary to the APPLGATE RIVER, for IRRIGATION OF 19.4 ACRES AND DOMESTIC USE FOR ONE FAMILY.

This right was perfected under Permit 20608. The date of priority is JULY 30, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.256 CUBIC FOOT PER SECOND (CFS), being 0.246 CFS for irrigation and 0.01 CFS for domestic use, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 8, AND NW $\frac{1}{4}$  NW $\frac{1}{4}$ , SECTION 17, T 40 S, R 3 W,  
W.M.

The amount of water used for irrigation, together with the amount secured under an other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

TOWNSHIP 40 SOUTH, RANGE 3 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 21618, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered OCT 05 1999, approving Transfer Application 6718.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
