CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BARRINGTON M. AND BONNIE E. GRANT

confirms the right to use the waters of the APPELEGATE RIVER AND APPELEGATE LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-7810, a tributary of the ROGUE RIVER, for PRIMARY IRRIGATION OF 7.2 ACRES AND SUPPLEMENTAL IRRIGATION OF 14.7 ACRES.

This right was perfected under Permit 47711. The date of priority is SEPTEMBER 22, 1983. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.09 CUBIC FOOT PER SECOND FOR PRIMARY IRRIGATION AND 14.6 ACRE-FEET STORED WATER ONLY FOR SUPPLEMENTAL IRRIGATION or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 8, T 40 S, R 3 W, W.M.; 425 FEET NORTH AND 525 FEET EAST FROM THE SW CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 4 $\frac{1}{2}$ acre-feet for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 3-07-10-W0475 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

PRIMARY IRRIGATION FROM THE APPELEGATE RIVER

SW $\frac{1}{4}$ SW $\frac{1}{4}$ 7.2 ACRES
SECTION 8

SUPPLEMENTAL IRRIGATION FROM APPELEGATE LAKE RESERVOIR

SW $\frac{1}{4}$ SW $\frac{1}{4}$ 14.7 ACRES
SECTION 8

TOWNSHIP 40 SOUTH, RANGE 3 WEST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 53707, State Record of Water Right Certificates, NOT canceled by an order of the Water Resources Director entered OCT 05 1999 , approving Transfer Application 6719.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
