## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

J.S. TELLVIK ROUTE 1, BOX 515 CAVE JUNCTION, OREGON 97523

confirms the right to use the waters of TELLVIK WELL in the DEMOCRAT CREEK BASIN for IRRIGATION OF 0.8 ACRE AND SUPPLEMENTAL IRRIGATION OF 42.0 ACRES.

This right was perfected under Permit G-2026. The date of priority is JANUARY 2, 1962. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.54 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW% NW%, AS PROJECTED WITHIN NEWMAN DLC 39, SECTION 6, T 40 S, R 7 W, W.M.; WELL LOCATED 2600 FEET SOUTH AND 200 FEET EAST FROM THE NW CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2% acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

This use may be regulated if analysis of data available discloses that the appropriation will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway in quantities necessary for recreation, fish and wildlife in effect as of the priority date of this right or as those quantities may be subsequently reduced.
