CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO
RICHARD AND MARGENE EIGUREN
JORDAN VALLEY, OREGON 97910

confirms the right to use the waters of WASTE WATER (DRY CREEK), a tributary of JORDAN CREEK, for SUPPLEMENTAL IRRIGATION OF 144.5 ACRES.

This right was perfected under Permit 31107. The date of priority is MARCH 8, 1966. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 2.41 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 3 (NE 1/4 NW 1/4), SECTION 3, T 31 S, R 42 E, W.M.; 630 FEET SOUTH AND 1570 EAST FROM NW CORNER OF SECTION 3.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year AND IS SUBJECT TO AN AGREEMENT BETWEEN THE JORDAN VALLEY IRRIGATION DISTRICT AND THE WATER USER RECORDED IN MISCELLANEOUS RECORDS OF THE WATER RESOURCES DEPARTMENT RECORDED IN VOLUME 4, PAGES 803 AND 804, LIMITING THE AMOUNT TO SUCH WASTE WATER AS MAY BE FROM TIME TO TIME AVAILABLE AT THE POINT OF DIVERSION ONLY. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


