CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of WELLS 8, 9, AND 10 in the HARBOR BASIN for the purpose of IRRIGATION AND TEMPERATURE CONTROL OF 6.0 ACRES, SUPPLEMENTAL IRRIGATION AND TEMPERATURE CONTROL OF 41.4 ACRES.

The right has been perfected under Permit G-7156. The date of priority is FEBRUARY 1, 1977. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.59 CUBIC FOOT PER SECOND (CFS), BEING 0.59 CFS FOR IRRIGATION AND SUPPLEMENTAL IRRIGATION OR 0.59 CFS FOR TEMPERATURE CONTROL, or its equivalent in case of rotation, measured at the point of diversion from the source.

The wells are located as follows:

WELL 8 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 170 FEET SOUTH AND 1440 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 9 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 20 FEET SOUTH AND 1590 FEET WEST FROM THE NE CORNER, SECTION 16; AND

WELL 10 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 570 FEET SOUTH AND 1590 FEET WEST FROM THE NE CORNER, SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.


