CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

OREGON PROPAGATING COMPANY

confirms the right to use the waters of WELLS 1 THROUGH 10 in the HARBOR BASIN for PRIMARY IRRIGATION AND TEMPERATURE CONTROL OF 21.1 ACRES AND SUPPLEMENTAL IRRIGATION AND TEMPERATURE CONTROL OF 4.6 ACRES.

This right was perfected under Permit G-9493. The date of priority is FEBRUARY 25, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.66 CUBIC FEET PER SECOND FROM WELLS 8, 9, AND 10 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY TO BE APPROPRIATED FROM WELLS 1 THROUGH 7, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 - NE 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; 680 FEET SOUTH AND 15 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 2 - NE 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; 520 FEET SOUTH AND 310 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 3 - NE 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; 1130 FEET SOUTH AND 270 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 4 - NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 42, SECTION 15, T 41 S, R 13 W, W.M.; 775 FEET SOUTH AND 190 FEET EAST FROM THE NE CORNER, SECTION 16;

WELL 5 - NE 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; 1125 FEET SOUTH AND 50 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 6 - NE 1/4 NE 1/4, SECTION 16, T 41 S, R 13 W, W.M.; 845 FEET SOUTH AND 205 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 7 - NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 43, SECTION 15, T 41 S, R 13 W, W.M.; 1120 FEET SOUTH AND 220 FEET EAST FROM THE NE CORNER, SECTION 16;

WELL 8 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 170 FEET SOUTH AND 1440 FEET WEST FROM THE NE CORNER, SECTION 16;

WELL 9 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 20 FEET SOUTH AND 1590 FEET WEST FROM THE NE CORNER, SECTION 16; AND

WELL 10 - LOT 4 (NW 1/4 NE 1/4), SECTION 16, T 41 S, R 13 W, W.M.; 570 FEET SOUTH AND 1590 FEET WEST FROM THE NE CORNER, SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


The wells shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The water user shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished.

The water user shall install and maintain a weir, meter, or other suitable measuring device, and shall keep a complete record of the amount of groundwater withdrawn.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.
