confirms the right to use the waters of the EAST CHANNEL of the WILLAMETTE RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION of 40.3 ACRES.

This right was perfected under Permit 22801. The date of priority is FEBRUARY 8,1954. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.50 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW% SW%, as projected within J. ROBINETT DLC 52, SECTION 6, T 12 S, R 4 W, WM; SE% NE%, as projected within JOSEPH ROBINETT DLC 77, SECTION 12, T 12 S , R 5 W, WM.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Pursuant to ORS 536.075 and OAR 127-004-080 and OAR 690-01-005, you may either petition for judicial reivew or petition the Director for reconsideration of this order.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
