CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE<sup>1</sup> ISSUED TO

DITCHEN LAND COMPANY  
7385 HOWELL PRAIRIE ROAD SE  
SILVERTON, OREGON 97381

confirms the right to use the waters of WELL 1 in the UMATILLA RIVER BASIN for SUPPLEMENTAL IRRIGATION of 123.6 ACRES.

This right was perfected under Permit G-8041. The date of priority is FEBRUARY 21, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 3.0 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 30, T 3 N, R 30 E, WM; 30 FEET SOUTH AND 640 FEET WEST FROM THE CENTER, SECTION 30.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NE $\frac{1}{4}$ NW $\frac{1}{4}$	9.2 ACRES
NW $\frac{1}{4}$ NW $\frac{1}{4}$	57.6 ACRES
SW $\frac{1}{4}$ NW $\frac{1}{4}$	56.8 ACRES


The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
