CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE¹ ISSUED TO

DITCHEN LAND COMPANY
7385 HOWELL PRAIRIE ROAD NE
SILVERTON, OREGON 97381

confirms the right to use the waters of WELL 2 in the UMATILLA RIVER BASIN for IRRIGATION of 260.0 ACRES and SUPPLEMENTAL IRRIGATION of 276.4 ACRES.

This right was perfected under Permit G-8367. The date of priority is AUGUST 2, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 4.38 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 20, T 3 N, R 30 E, WM; 100 FEET NORTH AND 80 FEET EAST FROM THE SW CORNER, SECTION 20.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

¹This is an order is other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005, you may either petition for judicial review or petition the Director for reconsideration of this order.



The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
