confirms the right to use the waters of MUDDY CREEK, MCKENZIE RIVER, LAKE CREEK, DRY MUDDY CREEK, and LITTLE MUDDY CREEK, tributaries of the WILLAMETTE RIVER, for IRRIGATION OF 3332.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 188.4 ACRES.

This right was perfected under Permit 17510. The date of priority is FEBRUARY 9, 1939. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 44.0 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
