confirms the right to use the waters of RUDIO CREEK AND NORTH FORK JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for PRIMARY IRRIGATION OF 83.2 ACRES FROM RUDIO CREEK WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM THE NORTH FORK JOHN DAY RIVER AND SUPPLEMENTAL IRRIGATION OF 112.2 ACRES FROM THE NORTH FORK JOHN DAY RIVER.

This right was perfected under Permit 44608. The date of priority is SEPTEMBER 4, 1979. This right is limited to 4.88 CUBIC FEET PER SECOND(CFS); BEING 2.08 CFS FROM RUDIO CREEK WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM THE NORTH FORK JOHN DAY RIVER AND 2.80 CFS FROM THE NORTH FORK JOHN DAY RIVER or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

RUDIO CREEK - SE 1/4 NE 1/4, SECTION 27, T 9 S, R 26 E, W.M.; 7120 FEET SOUTH AND 4200 FEET EAST FROM NORTHWEST CORNER SECTION 22; AND

NORTH FORK JOHN DAY RIVER - NW 1/4 SW 1/4, SECTION 15, T 9 S R 26 E, W.M.; 1370 FEET NORTH AND 100 FEET EAST FROM SOUTHWEST CORNER SECTION 15.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second (or its equivalent) and 5.0 acre-feet for each acre irrigated during the irrigation season of each year.


The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
