CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

F. JOHN RISSBERGER 22120 BUTTEVILLE ROAD NE AURORA, OREGON 97002

confirms the right to use the waters of WELLS NO.'S 1 AND 2 in the DEER CREEK BASIN for IRRIGATION OF 40.0 ACRES.

This right was perfected under Permit G-5574. The date of priority is JUNE 16, 1972. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.5 CUBIC FOOT PER SECOND, (IF AVAILABLE AT THE ORIGINAL WELL LOCATED NW 1/4 SE 1/4, AS PROJECTED WITHIN DLC 43, SECTION 8, TOWNSHIP 4 SOUTH, RANGE 1 WEST, W.M.; 1780 FEET NORTH AND 870 FEET EAST FROM THE SOUTH 1/4 CORNER OF SECTION 8), or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL NO. 1 - SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 42, SECTION 8, TOWNSHIP 4 SOUTH, RANGE 1 WEST, W.M.; 60 FEET NORTH AND 2320 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 8; AND

WELL NO. 2 - SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 42, SECTION 8, TOWNSHIP 4 SOUTH, RANGE 1 WEST, W.M.; 600 FEET NORTH AND 2180 FEET EAST FROM THE WEST 1/4 CORNER OF SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 NE 1/4 19.7 ACRES
SE 1/4 NE 1/4 7.5 ACRES
SE 1/4 NW 1/4 9.8 ACRES
NE 1/4 SW 1/4 2.1 ACRES

SECTION 8
TOWNSHIP 4 SOUTH, RANGE 1 WEST, W.M.

The well shall be maintained in accordance with the General Standards for the Construction and Maintenance of Water Wells in Oregon.

The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

The quantity of water diverted at the new points of appropriation, together with the quantity diverted at the old pont of appropriation, shall not exceed the quantity of water lawfully available from the original point of appropriation.

When required by the Department the water user shall install an in-line flow meter or other suitable device for measuring and recording the quantity of water sued. The type and plans of the measuring device must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department.

This certificate is issued to confirm a change in POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MARCH 9, 1998, and together with Certificate 75530, supersedes Certificate 46081, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
