## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of MORGAN CREEK WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM MORGAN CREEK TO BE MADE UP BY DIVERSION FROM THE SOUTH UMPQUA RIVER, a tributary of SOUTH UMPQUA RIVER, for IRRIGATION OF 12.0 ACRES AND STOCK.

This right was perfected under Permit 43691. The date of priority is OCTOBER 16, 1978. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.15 CUBIC FOOT PER SECOND (CFS), BEING 0.145 CFS FOR IRRIGATION AND 0.005 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

MORGAN CREEK (PORTABLE PUMPING ALONG CREEK) - SW 1/4 SW 1/4, SECTION 13, NE 1/4 NW 1/4, NW 1/4 NW 1/4, SECTION 24, AS PROJECTED WITHIN MORGAN DLC 54, TOWNSHIP 30 SOUTH, RANGE 5 WEST, W.M.; AND

SOUTH UMPQUA RIVER - NE 1/4 W 1/4, SECTION 24, AS PROJECTED WITHIN MORGAN DLC 54, TOWNSHIP 30 SOUTH, RANGE 5 WEST, W.M.; 1315 FEET SOUTH AND 1960 FEET EAST FROM THE NW CORNER, SECTION 24.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
