CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DON OLLIVANT
9937 LOOKINGGLASS ROAD
ROSEBURG, OREGON 97470

confirms the right to use the waters of LOOKINGGLASS CREEK, a tributary of SOUTH UMPQUA RIVER, for IRRIGATION OF 57.4 ACRES.

This right was perfected under Permit 20324. The date of priority is JULY 2, 1951. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.72 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 SE 1/4, NE 1/4 SE 1/4 AND NE 1/4 SW 1/4, SECTION 12, TOWNSHIP 28 SOUTH, RANGE 7 WEST, W.M.;

NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 39, SECTION 12, TOWNSHIP 28 SOUTH, RANGE 7 WEST, W.M., 1500 FEET NORTH AND 1050 FEET WEST FROM THE SE CORNER OF SECTION 12; AND

SW 1/4 SW 1/4, AS PROJECTED WITH DLC 40, SECTION 7, TOWNSHIP 28 SOUTH, RANGE 6 WEST, W.M., 1150 FEET NORTH AND 360 FEET EAST FROM THE SW CORNER OF SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JULY 15, 1981, and supersedes Certificate 24005, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
