confirms the right to use the waters of JORDAN SPRING AND RIMROCK SPRING, tributaries of WILLOW CREEK, for the purpose of WILDLIFE AND DOMESTIC USE.

This right was perfected under Permit 27531. The date of priority is JUNE 9, 1961. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.015 CUBIC FOOT PER SECOND(CFS); BEING 0.005 CUBIC FOOT PER SECOND FROM JORDAN SPRING FOR WILDLIFE USE AND 0.01 CUBIC FOOT PER SECOND FROM RIMROCK SPRING FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

JORDAN SPRING - SE 1/4 SW 1/4, SECTION 27, TOWNSHIP 12 SOUTH, RANGE 14 EAST, W.M.; 742 FEET NORTH AND 2953 FEET WEST FROM THE NE CORNER SECTION 34; AND

RIMROCK SPRING - NE 1/4 NW 1/4, SECTION 34, TOWNSHIP 12 SOUTH, RANGE 14 EAST, W.M.; 20 FEET SOUTH AND 3795 FEET WEST FROM THE NE CORNER SECTION 34.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 WILDLIFE USE
SECTION 27


NW 1/4 NW 1/4 DOMESTIC USE
TOWNSHIP 12 SOUTH, RANGE 14 EAST, W.M.

This certificate is issued to confirm a change in USE AND PLACE OF USE approved by an order of the Water Resources Director entered MARCH 10, 1982, and supersedes Certificate 35968, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
