CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TUMALO IRRIGATION DISTRICT
64697 COOK AVE
BEND, OREGON 97701

confirms the right to use the waters of CRESENT LAKE RESERVOIR CONSTRUCTED UNDER PERMIT R-2744, tributary of CRESENT CREEK AND LITTLE DESCHUTES RIVER, for SUPPLEMENTAL IRRIGATION OF 7366.57 ACRES.

This right was perfected under Permit 27841. The date of priority is DECEMBER 8, 1961. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 42,727 ACRE-FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

DESCHUTES RIVER (TUMALO IRRIGATION DISTRICT BEND FEED CANAL)- NW 1/4 NE 1/4, SECTION 32, TOWNSHIP 17 SOUTH, RANGE 12 EAST, W.M.; 2050 FEET WEST FROM THE NE CORNER OF SECTION 32; AND

CRESENT LAKE RESERVOIR - SE 1/4 SW 1/4, SECTION 11, TOWNSHIP 24 SOUTH, RANGE 6 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of not to exceed 9.91 acre-feet per acre for each acre irrigated during the irrigation season of each year and the right allowed hereunder for the appropriation of water for lands having a valid prior right shall be limited to the amount necessary to make up any deficiency in water available to said lands under said prior right and the amount allowed herein, together with the amount secured under any other right existing for said lands, shall be limited by the duty of water as fixed herein; and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


