CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

C & S FARMS  
10483 SOUTH TOWNSHIP ROAD  
CANBY, OREGON 97013

confirms the right to use the waters of CEREGHINO WELLS 1 AND 2 in the MOLALLA RIVER BASIN for IRRIGATION OF 16.0 ACRES.

This right was perfected under Permit G-10488. The date of priority is APRIL 16, 1985. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.20 CUBIC FOOT PER SECOND (CFS), BEING 0.06 CFS FROM WELL 1 AND 0.14 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - SW $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 35, T 3 S, R 1 E, W.M.; 1040 FEET NORTH AND 1890 FEET WEST FROM THE SE CORNER OF SECTION 35.

WELL 2 - NW $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 35, T 3 S, R 1 E, W.M.; 1700 FEET NORTH AND 1700 FEET WEST FROM THE SE CORNER OF SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre-feet per acre for each acre irrigated during the irrigation season of each year. In the event of a request for a change in point of appropriation, and additional point of appropriation, or repair of these wells, the quantity of water allowed herein together with any other right from these points of appropriation shall not exceed the capacity of these wells at the time of perfection of this right.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
