CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TUMALO TOWN DISTRICT IMPROVEMENT COMPANY
19806 2ND STREET
BEND, OREGON 97701

confirms the right to use the waters of THE DESCHUTES RIVER, a tributary of THE COLUMBIA RIVER, for IRRIGATING 3.98 ACRES.

This right was perfected under Permits 19750 & 21807. The dates of priority are AUGUST 3, 1950 and SEPTEMBER 30, 1952. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.087 CUBIC FOOT PER SECOND, being 0.02 cfs under the 1950 priority and 0.067 cfs under the 1952 priority, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW¼ SE¼, SECTION 6, T. 17 S., R. 12 E., W.M.; 2230 FEET NORTH AND 1650 FEET WEST FROM THE SE CORNER OF SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
