CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

TUMALO TOWN DISTRICT IMPROVEMENT COMPANY 19806 2ND STREET BEND, OREGON 97701

confirms the right to use the waters of THE DESCHUTES RIVER, a tributary of THE COLUMBIA RIVER, for IRRIGATING 3.495 ACRES, STOCK AND DOMESTIC USE.

This right was confirmed by decree of the Circuit Court of the State of Oregon for DESCHUTES County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 16, at Pages 33, 157, 180, 181, AND 186. The dates of priority are 1904, APRIL 1905, AND APRIL 15, 1905.

The use is limited to 0.0874 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW¼ SE¼, SECTION 6, T. 17 S., R. 12 E., W.M.; 2230 feet North and 1650 feet West from the SE Corner of Section 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated from April 1st to May 22nd, ONE-FORTIETH of one cubic foot per second (or its equivalent) for each acre irrigated from May 23rd to August 20th of each year, and ONE-EIGHTIETH of one cubic foot per second or its equivalent for each acre irrigated after August 20th of each year and shall be further limited to a diversion of not to exceed 4.0 acre-feet for each acre irrigated during the irrigation season of each year from April 1st to November 1st.

A description of the place of use to which this right is appurtenant is as follows:
