CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FLOWERREE FARMS, INC.

confirms the right to use the waters of WELL 2 in the FORT ROCK BASIN for IRRIGATION OF 125.0 ACRES.

This right was perfected under Permit G-9020. The date of priority is JUNE 11, 1980. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.56 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE $\frac{1}{4}$  SW $\frac{1}{4}$ , SECTION 8, T 27 S, R 19 E, WM; WELL 2 - 1320 FEET SOUTH AND 1300 FEET WEST, FROM THE CENTER  $\frac{1}{4}$  CORNER, SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

NW $\frac{1}{4}$ SW $\frac{1}{4}$	31.2 ACRES
SW $\frac{1}{4}$ SW $\frac{1}{4}$	31.2 ACRES
SE $\frac{1}{4}$ SW $\frac{1}{4}$	31.3 ACRES
