CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LOUISE W. SLY ROUTE 1, BOX 30 HALFWAY, OREGON 97834

confirms the right to use the waters of FOUR DRAINS in the PINE CREEK BASIN for the purpose of SUPPLEMENTAL IRRIGATION OF 41.9 ACRES.

This right has been perfected under Permit G-7882. The date of priority is AUGUST 22, 1977. This right is limited to 1.05 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the POINT OF DIVERSION FROM THE DRAINS.

The points of diversion are located as follows:

DRAIN 1 - NE 1/4 SW 1/4, SECTION 36, TOWNSHIP 7 SOUTH, RANGE 45 EAST, W.M.; BEING 1030 FEET SOUTH AND 800 FEET WEST FROM THE C 1/4 CORNER OF SECTION 36;

DRAIN 2 - SW 1/4 SW 1/4, SECTION 36, TOWNSHIP 7 SOUTH, RANGE 45 EAST, W.M.; BEING 1500 FEET SOUTH AND 1370 FEET WEST FROM THE C 1/4 CORNER OF SECTION 36;

DRAIN 3 - NE 1/4 SW 1/4, SECTION 36, TOWNSHIP 7 SOUTH, RANGE 45 EAST, W.M.; BEING 240 FEET SOUTH AND 1220 FEET WEST FROM THE C 1/4 CORNER OF SECTION 36; AND

DRAIN 4 - SW 1/4 SW 1/4, SECTION 36, TOWNSHIP 7 SOUTH, RANGE 45 EAST, W.M.; BEING 2560 FEET SOUTH AND 2440 FEET WEST FROM THE C 1/4 CORNER OF SECTION 36.

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3.0 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
