CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ARTHUR B. HANSGEN AND CHARLES R. BUSHONG
4500 LEONARD ROAD
GRANTS PASS, OREGON 97526

confirms the right to use the waters of THE ROGUE RIVER, a tributary of PACIFIC OCEAN, for SUPPLEMENTAL IRRIGATION OF 6.43 ACRES.

This right was perfected under Permit 39204. The date of priority is JUNE 3, 1974. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.08 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

LOT 7 (NW 1/4 NE 1/4), SECTION 21, T 36 SOUTH, R 6 WEST, W.M.;
DIVERSION NO. 1 - 1920 FEET NORTH AND 2450 FEET WEST; DIVERSION NO. 2 - 1950 FEET NORTH AND 2570 FEET WEST, BOTH FROM E 1/4 CORNER OF SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
