CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to waters of COW CREEK, a tributary of SOUTH UMPQUA RIVER, for IRRIGATION OF 35.0 ACRES.

This right was perfected under Permit 5831. The date of priority is APRIL 7, 1923. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.44 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SE 1/4 NE 1/4, SECTION 33, AS PROJECTED WITH J. CATCHING DLC 40, TOWNSHIP 30 SOUTH, RANGE 6 WEST, W.M.; 369 FEET SOUTH AND 1269 FEET EAST FROM THE NW CORNER OF DLC 40;

SW 1/4 NW 1/4, SECTION 34, AS PROJECTED WITH J. CATCHING DLC 40, TOWNSHIP 30 SOUTH, RANGE 6 WEST, W.M.; 1750 FEET SOUTH AND 220 FEET EAST FROM THE NW CORNER OF SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SE 1/4 NE 1/4	29.0 ACRES
SW 1/4 NE 1/4	2.0 ACRES
NE 1/4 SE 1/4	2.0 ACRES

ALL AS PROJECTED WITH J. CATCHING CLC 40
SECTION 33

SW 1/4 NW 1/4 2.0 ACRES
AS PROJECTED WITH J. CATCHING CLC 40
SECTION 34
TOWNSHIP 30 SOUTH, RANGE 6 WEST, W.M.

When in the judgment of the Watermaster it becomes necessary to install head gates and measuring devices:

The diversion works shall include an in-line flow meter, a weir, or other suitable device for measuring the water to which the water user is entitled; and


The type and plans of the measuring device be approved by the Watermaster before the beginning of construction work and that the weir or measuring device be installed under the general supervision of said Watermaster.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered SEPTEMBER 8, 1981, and supersedes Certificate 6679, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
