CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THEODORE R. TIAHRT OF DOUBLE TREE RANCH  
HC 84, BOX 155  
SILVER LAKE, OREGON 97638

confirms the right to use the waters of WELLS 4 and 5 in the CHRISTMAS VALLEY BASIN for PRIMARY IRRIGATION OF 544.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 520.0 ACRES.

This right was perfected under Permit G-8551. The date of priority is FEBRUARY 8, 1979. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 7.05 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL NO. 4 - NE 1/4 NW 1/4, SECTION 23, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.; 1310 FEET SOUTH AND 2530 FEET EAST FROM THE NW CORNER OF SECTION 23; AND

WELL NO. 5 - NE 1/4 SW 1/4, SECTION 23, TOWNSHIP 26 SOUTH, RANGE 15 EAST, W.M.; 1330 FEET NORTH AND 1330 FEET EAST FROM THE SW CORNER OF SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
