CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of AN UNNAMED SPRING, a tributary of SOUTH FORK COQUILLE RIVER, for DOMESTIC USE FOR TWO HOUSEHOLDS INCLUDING IRRIGATION OF UP TO ONE-HALF ACRE LAWN AND NON-COMMERCIAL GARDEN AND HUMAN CONSUMPTION FOR ONE POST OFFICE.

This right was perfected under Permit 53035. The date of priority is DECEMBER 26, 1995. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.015 CUBIC FOOT PER SECOND (CFS): FURTHER LIMITED TO 0.01 CFS FOR HUMAN CONSUMPTION ONLY FOR THE TWO HOUSEHOLDS DURING MAY 1 TO JUNE 15 AND OCTOBER 1 THROUGH NOVEMBER 30; 0.01 CFS FOR DOMESTIC USE FOR TWO HOUSEHOLDS INCLUDING THE IRRIGATION OF ONE-HALF ACRE LAWN AND NONCOMMERCIAL GARDEN DURING DECEMBER 1 THROUGH APRIL 30 AND JUNE 15 THROUGH SEPTEMBER 30; AND 0.01 CFS FOR HUMAN CONSUMPTION ONLY FOR THE TWO FAMILIES AND POST OFFICE DURING THE PERIOD JUNE 15 TO SEPTEMBER 30 WHEN THE SPRING CONTRIBUTES FLOW TO THE SOUTH FORK COQUILLE RIVER, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 32, TOWNSHIP 29 SOUTH, RANGE 12 WEST, W.M.;
477 FEET NORTH AND 958 FEET WEST FROM THE SE CORNER OF SECTION 32.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW 1/4 SE 1/4
SECTION 32
TOWNSHIP 29 SOUTH, RANGE 12 WEST, W.M.

Measurement, recording and reporting conditions:

- A. The Director may require the water user to install a meter or other suitable measuring device as approved by the Director. If the Director notifies the water user to install a meter or other measuring device, the water user shall install such device within the period stated in the notice. Such installation period shall not be less than 90 days unless special circumstances warrant a shorter installation period. Once installed, the water user shall maintain the meter or measuring device in good working order and shall allow the watermaster access to the meter or measuring device. The Director may provide an opportunity for the water user to submit alternative measuring procedures for review and approval.

- B. The Director may require the water user to keep and maintain a record of the amount (volume) of water used and may require the water user to report water use on a periodic schedule as established by the Director. In addition, the Director may require the water user to report general water use information, the periods of water use and the place and nature of use of water under the right. The Director may provide an opportunity for the water user to submit alternative reporting procedures for review and approval.

Failure to comply with any of the provision of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to use water for the above purpose is restricted to beneficial use, without waste, on the lands or place of use described. The water user is advised that new regulations may require use of best practical technologies or conservation practices to achieve this end.


By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The use of water shall be limited when it interferes with any prior surface or ground water rights.

The Director finds the use(s) of water described by this right, as conditioned, will not impair or be detrimental to the public interest.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
