CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of the ROGUE RIVER, a tributary of the PACIFIC OCEAN, for the purpose of the FROST CONTROL AND IRRIGATION OF 10.3 ACRES AND FROST CONTROL FOR 129.8 ACRES.

This right has been perfected under Permit 39303. The date of priority is JULY 18, 1974. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 18.26 CUBIC FEET PER SECOND (CFS), BEING 0.26 CFS FOR IRRIGATION AND 18.00 CFS FOR FROST CONTROL, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 1 (NE 1/4 NE 1/4), SECTION 19, T 36 S, R 6 W, W.M.; 650 FEET SOUTH AND 110 FEET WEST FROM THE NE CORNER OF SECTION 19; AND

LOT 4 (NW 1/4 NW 1/4), SECTION 20, T 36 S, R 6 W, W.M.; 450 FEET SOUTH AND 750 FEET EAST FROM THE NE CORNER OF SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

This right shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the place of use under this right, and to which this right is appurtenant, is as follows:
