CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ELMER L. COOK
ROUTE 2, BOX 144
ALBANY, OREGON 97321

confirms the right to use the waters of WELLS 1 AND 2 in the SANTIAM RIVER BASIN for the purpose of IRRIGATING 37.1 ACRES.

The right has been perfected under Permit G-2486. The date of priority is JULY 5, 1963. The right is limited to not more than 0.46 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

WELL 1 - NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 56, SECTION 33, T 9 S, R 3 W., W.M.; 3340 FEET SOUTH AND 1390 FEET WEST FROM THE NE CORNER OF DLC 56; AND

WELL 2 - NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 56, SECTION 33, T 9 S, R 3 W., W.M.; 1970 FEET NORTH AND 2000 FEET WEST FROM THE SE CORNER OF DLC 56.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:



This certificate is issued to confirm an ADDITIONAL POINT OF APPROPRIATION approved by an order of the Water Resources Director entered MAY 13, 1985, APPROVING TRANSFER APPLICATION NO. T-5618, CONFIRMS THE PORTION OF THE RIGHT NOT CANCELED BY ORDER ENTERED MAY 13, 1995, RECORDED IN VOLUME 39, PAGE 180, ORDER RECORD OF THE WATER RESOURCES DIRECTOR and supersedes certificate 41791, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
