CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROSEBURG FOREST PRODUCTS
P.O. BOX 1088
ROSEBURG, OREGON 97470

confirms the right to use the waters of COW CREEK AND RESERVOIR UNDER CERTIFICATE 19783, a tributary of the SOUTH UMPQUA RIVER, for MANUFACTURING AND FIRE PROTECTION.

This right supercedes CERTIFICATE 19784. The date of priority is AUGUST 9, 1950 PLUS ONE MINUTE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.20 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE1/4 NW1/4, AS PROJECTED ON JAMES CATCHING D.L.C. #43, SECTION 26, TOWNSHIP 30 SOUTH, RANGE 6 WEST, W.M.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to confirm an ALLOCATION OF CONSERVED WATER approved by an order of the Water Resources Director entered JULY 06, 2000, and together with Certificates 76587 and 76589, supersedes Certificate 19784, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
