CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SUTHERLIN WATER CONTROL DISTRICT

SUTHERLIN, OREGON 97479

confirms the right to use the waters of SUTHERLIN CREEK AND PLAT I RESERVOIR CONSTRUCTED UNDER PERMIT R-4751, a tributary of NORTH UMPQUA RIVER, for PRIMARY IRRIGATION OF 499.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 34.6 ACRES.

This right was perfected under Permit 31273. The date of priority is JANUARY 27, 1960. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 6.67 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 SE 1/4, SECTION 14, AS PROJECTED WITHIN J. SUTHERLIN DLC 41, TOWNSHIP 25 SOUTH, RANGE 5 WEST, W.M.; 800 FEET SOUTH AND 580 FEET EAST FROM THE C 1/4 CORNER, SECTION 14.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. The use of water for supplemental irrigation is limited to stored water only.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:
