CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JESS ROBERTS HC 60 BOX 2600 LAKEVIEW, OR 97630

confirms the right to use the water of A WELL in the ANTELOPE CREEK BASIN for the purpose of PRIMARY IRRIGATION of 79.32 ACRES and SUPPLEMENTAL IRRIGATION of 175.0 ACRES.

The right was perfected under PERMIT G-7696. The date of priority is JULY 21, 1977. The right is limited to not more than 3.18 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW¼ SE¼, Section 5, Township 40 South, Range 19 East, W. M.; 1570 feet north and 93 feet east from S¼ Corner Section 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same lands and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
