confirms the right to store the waters of THE DRAINAGE AREA DRAINING INTO CRESENT LAKE, a tributary of CRESENT CREEK AND LITTLE DESCHUTES RIVER, in CRESENT LAKE RESERVOIR, for MULTIPLE PURPOSE USES AS PROVIDED BY DECREE OF THE CIRCUIT COURT OF DESCHUTES COUNTY, OREGON, DATED FEBRUARY 10, 1928 AS MODIFIED, IN THE MATTER OF THE DETERMINATION OF THE RELATIVE RIGHTS TO THE USE OF THE WATERS OF THE DESCHUTES RIVER AND ITS TRIBUTARIES, A TRIBUTARY OF COLUMBIA RIVER.

The right to store these waters was perfected under Reservoir Permit R-102. The date of priority is MARCH 20, 1911. The amount of water entitled to be stored each year under this right is not more than 35,000 ACREFEET AND THE MAXIMUM QUANTITY OF WATER STORED AT ANY TIME SHALL NOT EXCEED 86,050 ACRE-FEET.
