## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

VERLE EMERY P.O. BOX 510 LAKEVIEW, OREGON 97630

confirms the right to use the waters of WELLS 1 AND 2 in the SUMMER LAKE BASIN for IRRIGATION OF 103.9 ACRES.

This right was perfected under Permit G-10388. The date of priority is MARCH 27, 1984. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 1.30 CUBIC FOOT PER SECOND (CFS), BEING 0.46 CFS FROM WELL 1 AND 0.84 CFS FROM WELL 2, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NE% NE%, SECTION 15, SE% SW%, SECTION 10, TOWNSHIP 31 SOUTH, RANGE 16 EAST, W.M.; WELL 1 - 840 FEET SOUTH AND 950 FEET WEST FROM THE NE CORNER, SECTION 15; WELL 2 - 1439 FEET SOUTH AND 484 FEET WEST FROM THE C% CORNER, SECTION 10.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
