CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HERBERT JONES, JR.  
STAR ROUTE BOX 17  
FRESNO, CALIFORNIA

confirms the right to use the waters of SNOW CREEK, a tributary of COW CREEK, for IRRIGATION OF 12.3 ACRES.

This right was perfected under Permit 25833. The date of priority is OCTOBER 10, 1958. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.17 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 6, T 32 S, R 3 W, W.M.; 4580 FEET SOUTH AND 2430 FEET WEST  
FROM NE CORNER, SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-SEVENTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 $\frac{1}{2}$  acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right to the use of water is limited to the period when the flow of water in Cow Creek is 11.0 cubic feet per second or more at its mouth.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:

SW $\frac{1}{4}$ NE $\frac{1}{4}$	0.2 ACRES
SE $\frac{1}{4}$ NW $\frac{1}{4}$	5.9 ACRES
NE $\frac{1}{4}$ SW $\frac{1}{4}$	5.4 ACRES
NW $\frac{1}{4}$ SE $\frac{1}{4}$	0.7 ACRES
SW $\frac{1}{4}$ SE $\frac{1}{4}$	0.1 ACRES


This certificate is issued to correct a scrivener's error contained in the certificate recorded at page 76635, State Record of Water Right Certificates. Certificate 76635 incorrectly described the amount of water to which the right is entitled. This certificate supersedes Certificate 76635.

This certificate describes that portion of the water right confirmed by Certificate 37097, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered December 6, 2000, and recorded at Special Order Volume 54, Page 879, approving Transfer Application 8306.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
