CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STATE OF OREGON WATER RESOURCES DEPARTMENT SALEM, OREGON 97301

confirms the right to use the waters of JENNY CREEK, a tributary of the KLAMATH RIVER, for INSTREAM USES.

This right was perfected under Permit 7019. The date of priority is OCTOBER 26, 1925. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.75 CUBIC FOOT PER SECOND (CFS); BEING 0.45 CFS AT EAST DITCH DIVERSION, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION, NW¼ NW¼, SECTION 22, TOWNSHIP 40 SOUTH, RANGE 4 EAST, W.M.; WILLIAMS DITCH DIVERSION - NORTH 25 DEGREES 41 MINUTES EAST 1796 FEET FROM THE W¼ CORNER, SECTION 22 AND 0.30 CFS AT WILLIAMS DITCH DIVERSION or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

EAST DITCH - SE¼ NW¼, SECTION 16, TOWNSHIP 40 SOUTH, RANGE 4 EAST, W.M.; 1450 FEET NORTH AND 3060 FEET WEST FROM THE SE CORNER OF SECTION 16; AND

WILLIAMS DITCH DIVERSION - NW¼ NW¼, SECTION 22, TOWNSHIP 40 SOUTH, RANGE 4 EAST, W.M.; NORTH 25 DEGREES 41 MINUTES EAST 1796 FEET FROM THE W ¼ CORNER, SECTION 22.

The instream right created by this right is limited to 0.75 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source, DURING THE PERIOD OF THE IRRIGATION SEASON OF APRIL 1 TO OCTOBER 31, if available at the original point of diversion of the rights. The date of priority is OCTOBER 26, 1925.

The reach of the instream right is described as follows:

Upstream point: 0.45 CFS - EAST DITCH - SE¼ NW¼, SECTION 16, TOWNSHIP 40 SOUTH, RANGE 4 EAST, W.M.; 1450 FEET NORTH AND 3060 FEET WEST FROM THE SE CORNER OF SECTION 16; AND 0.30 CFS - WILLIAMS DITCH DIVERSION - NW¼ NW¼, SECTION 22, TOWNSHIP 40 SOUTH, RANGE 4 EAST, W.M.; NORTH 25 DEGREES 41 MINUTES EAST 1796 FEET FROM THE W ¼ CORNER, SECTION 22. Downstream point: THE OREGON - CALIFORNIA BORDER, IN THE SW¼ SW¼, SECTION 9, TOWNSHIP 41 SOUTH, RANGE 4 EAST, W.M.

This certificate describes that portion of the water right confirmed by Certificate 76239, State Record of Water Right Certificates, modified by the provisions of an order of the Water Resources Director entered FEBRUARY 16, 2001, approving Transfer Application 8504.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
