## STATE OF OREGON COUNTY OF UMATILLA CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

WESTLAND IRRIGATION DISTRICT P.O. BOX 416 STANFIELD, OREGON 97875

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION, AND STOCK WATER OF 61.6 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Pages 246-247 and Volume 15, at Pages 437-439. The date of priority is MARCH 14, 1903.

The use is limited to 0.77 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the Umatilla River.

The point of diversion is located as follows:

NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM THE WEST 1/4 CORNER OF SECTION 21, BEING WITHIN SW ¼ NE ¼ OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M. UMATILLA COUNTY.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.

(These lands were also allowed a right to use the waters of the Umatilla River as recorded in Volume 3, at Page 228, in the names of Wm. H. Gulliford and Sadie Haney, through the Pioneer - Courtney Ditch with a priority of January 9, 1900.)

This certificate describes that portion of the water right confirmed by the Umatilla Decree recorded at Volume 3 Page 246-247, in the name of Western Land and Irrigation Company, and Volume 15, at Pages 437-439, in the name of Westland Irrigation District, State Record of Water Rights, NOT modified by an order of the Director entered on February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
