CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO:

confirms the right to use the waters of the UMATILLA RIVER, a tributary of the COLUMBIA RIVER, for IRRIGATION, AND STOCK WATER OF 103.9 ACRES.

This right was confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA COUNTY. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 3, at Pages 247-249 and Volume 15, at Pages 439-441 and Volume 16, at Pages 459-460; as modified by an Order of the Director entered on March 17, 1986, at Special Order Volume 40 Page 137, approving a change in place of use under Transfer 5766; and as modified by an Order of the Director entered on April 5, 1990, at Special Order Volume 44 Page 165, approving a change in point of diversion under Transfer 5869.

The date of priority is JULY 1907.

The use is limited to 1.3 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the Umatilla River.

The points of diversion are located as follows:

NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM THE WEST 1/4 CORNER OF SECTION 21, BEING WITHIN SW 1/4 NE 1/4 OF SECTION 21, TOWNSHIP 3 NORTH, RANGE 29 EAST, W.M. UMATILLA COUNTY.

POD # 2 - 660 FEET NORTH AND 10 FEET EAST FROM THE SW CORNER OF SECTION 16, BEING WITHIN SW 1/4 SW 1/4 OF SECTION 16, TOWNSHIP 4 NORTH, RANGE 28 EAST, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) from MARCH 1 to NOVEMBER 1 and subject to the limitations of paragraph 32 of the Umatilla River Decree for each acre irrigated during the irrigation season of each year.



This certificate describes that portion of the water right confirmed by the Umatilla Decree recorded at Volume 3 Page 247-249, in the name of Western Land and Irrigation Company, and Volume 15 at Pages 439-441 and Volume 16 at Pages 459-460, in the name of Westland Irrigation District; State Record of Water Rights, NOT modified by an order of the Director entered on February 26, 2001 and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district; and confirms an Order of the Director entered on March 17, 1986, at Special Order Volume 40 Page 137, approving a change in place of use under Transfer 5766; and confirms an Order of the Director entered on April 5, 1990, at Special Order Volume 44 Page 165, approving a change in point of diversion for 28.2 acres under Transfer 5869.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and is subject to all other conditions and limitations contained in said decree.
