CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WESTLAND IRRIGATION DISTRICT
P.O. BOX 406
STANFIELD, OREGON 97875

confirms the right to use the waters of UMATILLA RIVER, a tributary of COLUMBIA RIVER for IRRIGATION OF 160.0 ACRES.

This right was perfected under Permit 40238. The date of priority is FEBRUARY 23, 1976. This right is limited to not more than 2.0 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW ¼ NE ¼, SECTION 21, T 3 N, R 29 E, W.M.; NORTH 76 DEGREES 45 MINUTES 56 SECONDS EAST 2913.19 FEET FROM W ¼ CORNER, SECTION 21.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate is issued to confirm an order of the Water Resources Director entered February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district. The certificate supersedes Certificate 51294, State Record of Water Right Certificates.
