CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STONE MACHINERY COMPANY
P.O. BOX 1097
WALLA WALLA, WA 99362

confirms the right to use the waters of TWO WELLS in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 212.4 ACRES AND SUPPLEMENTAL IRRIGATION OF 226.7 ACRES.

This right was perfected under Permit G-3530. The date of priority is MAY 24, 1967. This right is limited to not more than 4.77 CUBIC FEET PER SECOND, BEING 2.9 CFS FROM WELL #1 AND 1.87 CFS FROM WELL #2; or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

WELL 1 - NW ¼ NE ¼, SECTION 18, T 3 N, R 28 E, W.M.;
1220 FEET SOUTH AND 1760 FEET WEST FROM NE ¼ CORNER, SECTION 18.
WELL 2 - SW ¼ SE ¼, SECTION 6, T 3 N, R 28 E, W.M.;
80 FEET NORTH AND 350 FEET EAST FROM S 1/4 CORNER, SECTION 6.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein. The right allowed herein shall not authorize appropriation from the aquifer supplying those wells described in the State Engineer's Ground Water Report No. 11 as "Deep Wells in Basalt" unless appropriations are permitted in the Umatilla Basin Program, OAR 690-507-610 to 690-507-700 declaring the aquifer a critical groundwater area.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



This certificate describes that portion of the water right confirmed by certificate 41252, State Record of Water Right NOT modified by an order of the Water Resources Director entered on February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
