CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

BETZ FARMS
240 E. MCKINNEY AVENUE
HERMISTON, OR 97838

confirms the right to use the waters of A WELL in the UMATILLA RIVER BASIN, for SUPPLEMENTAL IRRIGATION OF 130.3 ACRES.

This right was perfected under Permit G-3895. The date of priority is NOVEMBER 13, 1967. This right is limited to not more than 1.64 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows: SE ¼ SE ¼, SECTION 30, T 4 N, R 28 E, W.M.; 200 FEET NORTH AND 540 FEET WEST FROM SE CORNER, SECTION 30.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described, and is subject to all other conditions and limitations contained in said permit.

This certificate is issued to confirm an order of the Water Resources Director entered February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district. The certificate, together with Certificate 76743, and an order of the director approving Transfer T-6417 (Special Order Vol 46 Page 411), supersedes Certificate 44897, State Record of Water Right Certificates.
