CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of BUTTER CREEK AND TRIBUTARIES, a tributary of the UMATILLA RIVER, for SUPPLEMENTAL IRRIGATION OF 71.9 ACRES.

This right was perfected under Permit 2102. The date of priority is JULY 3, 1914. This right is limited to not more than 0.84 CUBIC FOOT PER SECOND; or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows: NE ¼ NW ¼, SECTION 8, T 3 N, R 28 E, W.M.; NORTH 81 DEGREES 25 MINUTES WEST, 1388 FEET TO SW CORNER, SECTION 5.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.


A description of the place of use to which this right is appurtenant is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate is issued to confirm an order of the Water Resources Director entered February 26, 2001 and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district, and confirms an order of the Director entered on February 2001, and recorded in Special Order Volume 55, Page 99 diminishing 9.5 acres to supplemental irrigation. This certificate, together with Certificate 76753, supersedes Certificate 2847, State Record of Water Right Certificates.
