CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN M. CORREA
ROUTE 1, BOX 23
ECHO, OREGON 97875

confirms the right to use the waters of AN UNNAMED DRAIN DITCH, a tributary of the UMATILLA RIVER, for IRRIGATION OF 30.4 ACRES.

This right was perfected under Permit 28053. The date of priority is MAY 4, 1962. This right is limited to not more than 0.6 CUBIC FOOT PER SECOND; or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW $\frac{1}{4}$ SE $\frac{1}{4}$, SECTION 11, T 3 N, R 28 E, W.M.;
4610 FEET SOUTH AND 2630 FEET WEST FROM NE CORNER, SECTION 11.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FIFTIETH of one cubic foot per second (or its equivalent) and 4 acre-feet for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by certificate 36919, State Record of Water Right NOT modified by an order of the Water Resources Director entered on February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
