confirms the right to use the waters of A DRAIN DITCH, a tributary of UMATILLA RIVER for SUPPLEMENTAL IRRIGATION OF 13.3 ACRES.

This right was perfected under Permit 45825. The date of priority is NOVEMBER 21, 1980. This right is limited to not more than 0.33 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows: NW¼ NE¼, SECTION 9, T 4 N, R 28 E, W.M.; 800 FEET SOUTH AND 460 FEET EAST FROM N 1/4 CORNER, SECTION 9.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-FORTIETH of one cubic foot per second per acre, (or its equivalent) and 4.5 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.
