CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

THOMAS E. HUDDLESTON
ROUTE 1, BOX 101
HERMISTON, OR 97838

confirms the right to use the waters of WELL No. 1 in the UMATILLA RIVER BASIN, for PRIMARY IRRIGATION OF 101.3 ACRES AND SUPPLEMENTAL IRRIGATION OF 76.3 ACRES.

This right was perfected under Permit G-2592. The date of priority is JANUARY 21, 1964. This right is limited to not more than 2.22 CUBIC FEET PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows: NE ¼ SW ¼, SECTION 18, T 4 N, R 28 E, W.M.;
10 FEET SOUTH AND 1110 FEET EAST FROM W 1/4 CORNER, SECTION 18.

The amount of water used for irrigation together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second (or its equivalent) and 3 acre-feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for supplemental irrigation shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.

This certificate describes that portion of the water right confirmed by certificate 34586, State Record of Water Right NOT modified by an order of the Water Resources Director entered on February 26, 2001, and recorded in Special Order Volume 55, Page 36, approving a petition by Westland Irrigation District under ORS 541.329 for mapping water rights within a district.

The issuance of this superceding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
