CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MARVIN SAMS  
53012 COUNTY ROAD  
MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of the LITTLE WALLA WALLA RIVER, a tributary of the WALLA WALLA RIVER, for IRRIGATION of 5.02 ACRES.

This right was perfected under Permit 1216. The date of priority is MARCH 25, 1912 PLUS ONE MINUTE. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.035 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE $\frac{1}{4}$  SE $\frac{1}{4}$ , SECTION 35, T 6 N, R 35 E, WM; 5 FEET NORTH AND 1100 FEET WEST FROM THE SE CORNER, SECTION 35.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:


NW $\frac{1}{4}$ SE $\frac{1}{4}$	1.82 ACRES
SW $\frac{1}{4}$ SE $\frac{1}{4}$	2.30 ACRES
SE $\frac{1}{4}$ SE $\frac{1}{4}$	0.68 ACRES
NE $\frac{1}{4}$ SE $\frac{1}{4}$	0.22 ACRES

SECTION 33  
TOWNSHIP 6 NORTH, RANGE 35 EAST, W.M.

This certificate is issued to confirm the new place of use and rate of diversion allowed under the provisions of an order of the Water Resources Director entered September 1, 1999, in Volume 53, Page 1191, Special Order Records of the Water Resources Department, approving Allocation of Conserved Water Application 7 and supersedes Certificate 76329, State Record of Water Right Certificates.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The use confirmed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
