CERTIFICATE OF WATER RIGHT

confirms the right to store the waters of AN UNNAMED STREAM, a tributary of SEVENMILE SLOUGH, in TWO UNNAMED RESERVOIRS, appropriated under Permit 51380, for CRANBERRY OPERATIONS.

The right to store these waters was perfected under Reservoir Permit R-11422. The date of priority is JULY 5, 1990. The amount of water entitled to be stored each year under this right is not more than 8.5 acre-feet (AF), BEING 2.5 AF IN RESERVOIR NO. 1 AND 6.0 AF IN RESERVOIR NO. 2.

The reservoirs are located as follows:

NE 1/4 SW 1/4 RESERVOIR NO. 2
NW 1/4 SE 1/4 RESERVOIR NO. 1
SECTION 3
TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

When in the judgment of the watermaster it becomes necessary to regulate waters of the stream system, use of water shall be subject to the installation of suitable devices for measuring flows diverted into Reservoir No. 1 from incoming natural flows of basin into reservoir and outflows from the reservoir. The types and plans for such devices shall be approved by the watermaster and shall be installed under the general supervision of said watermaster. Outflow will equal inflow from June 1 to October 31 in Reservoir No. 1.

The storage of water allowed herein is subject to the installation and maintenance of an outlet pipe, or the provisions of other means to evacuate water when determined necessary by the Water Resources Director to satisfy prior downstream rights.


Failure to comply with any of the provision of this right may result in action including, but not limited to, restrictions on the use, civil penalties, or cancellation of the right.

The right to use water for the above purpose is restricted to beneficial use, without waste, on the lands or place of use described. The water user is advised that new regulations may require use of best practical technologies or conservation practices to achieve this end.

By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan.

The storage of water allowed herein may be made only at times when sufficient water is available to satisfy all prior rights, including rights for maintaining instream flows.
