CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STARK ORCHARDS
THE DALLES, OREGON

confirms the right to use the waters of STARK ORCHARDS WELL in the THREEMILE CREEK (COLUMBIA RIVER) BASIN for IRRIGATION 108.4 ACRES.

This right was perfected under Permit U-756. The date of priority is JULY 19, 1955. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.89 CUBIC FOOT PER SECOND, or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SE 1/4 SE 1/4, SECTION 28, TOWNSHIP 1 NORTH, RANGE 13, EAST, W.M.; 2250 FEET SOUTH AND 800 FEET WEST FROM THE EAST 1/4 CORNER OF SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The use shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use to which this right is appurtenant is as follows:



The right to use water for the above purpose is restricted to beneficial use on the lands or place of use described.

THIS CERTIFICATE IS ISSUED TO CORRECTLY DESCRIBE THE LOCATION OF THE POINT OF APPROPRIATION AND SUPERSEDES CERTIFICATE 32601.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.
